This federal EPA Renovation, Repair, and Painting (RRP) rule applies to contractors, painters, plumbers, carpenters, electricians, window replacers, roofers, and landlords. Go 100 feet and turn right into Donald B. Smith Government Campus. The Putnam County Emergency Services/TOPS building is located at the rear of the campus, end of parking lot.

#### From North:

Route 84 East to Exit 19. Turn right onto Route 312. Go 1.4 miles and make a right onto Route 6. Go 1.0 miles and turn left at second traffic light onto Old Route 6. Go 100 feet and turn right into Donald B. Smith Government Campus. The Emergency Services Building is located at the rear of the campus.

### From West:

Bear Mountain Bridge to Route 9D North. Rte. 9D to Route 9 North. Get on Route 84 East (follow directions from North).

Or

Route 9 to 301 (to end in Carmel) - Make right (at traffic light) onto Route 6/52 - Make a left at the next light to continue following Route 6. Make right (second light) onto Old Route 6. Go 100 feet – Donald B. Smith Government Campus will be on your right. The PC Emergency Services Building is located at the rear of the campus.
