Recommend accepting the bid award for First Student, Inc. of Cincinnati, OH, for Cooperative Transportation Bid #2526-02. This contract will cover student transportation services, including hometo-school runs, field trips, and sporting events, for Spackenkill UFSD and Dutchess BOCES during the 2025-2026 school year.

The bid was advertised in the Poughkeepsie Journal and on the Dutchess BOCES website. First Student, **Inc.** was the sole bidder. They have a long-standing relationship with our districts, providing transportation services since February 2016 under various names, including MAT Bus Corp. and Total Transportation. While they were unwilling to extend their previous contract due to necessary price revisions, the attached document outlines the new pricing for all services.

The contract will be from July 1, 2025 thru June 30, 2026.

SUBJECT: Cooperative Transportation Bid #2526-02

Following the formal solicitation process for RFB #2526-02, First Student LLC was the sole respondent. As the incumbent vendor, First Student has provided transportation services under their current pricing model since 2019. Due to rising operational costs, the vendor indicated that it could no longer sustain services under the existing contract rates and was unable to proceed with an extension. As a result, a new Request for Bids (RFB) was issued in accordance with General Municipal Law §103, and the process was conducted in full compliance with all applicable competitive bidding requirements.

The proposal submitted by First Student reflects a 34.7% increase over the existing pricing. This increase is consistent with economic trends: the Consumer Price Index for All Urban Consumers (CPI-U) has increased by roughly 24.7% over the same period, per the U.S. Bureau of Labor Statistics. The remaining cost differential can largely be attributed to new safety requirements, including the mandatory installation of cameras on all school buses. These systems enhance student safety but introduce new hardware and data infrastructure costs.

This cost increase is calculated utilizing the routes that were current at the time of publishing the RFB, and estimates based upon this usage place the estimated cost at \$7,020,786.50 for the 25-26 SY. These calculations however do not include the monitors/aides, field trips, or other additional cost items. I have attached a worksheet showing these calculations.

Given First Student's performance history, the economic justification for the price adjustment, and the vendor's compliance with updated safety regulations, it is recommended that the contract for RFB #2526-02 be awarded to First Student LLC.

The primary drivers of the increase are the increase in costs. of the 34.8% increase from 2020 pricing, CPI accounts for 24.7% of it.

The secondary driver of the cost increase is the addition of the camera requirement in EVERY bus with ability for BOCES and the district(s) to be able to access the footage. This includes cloud storage, 2D compliance and all other technical requirements.
