2. INTRODUCTION & BACKGROUND

Dutchess BOCES is seeking qualified vendor(s) to provide student transportation services as required by Dutchess BOCES and participating school districts in the Cooperative Bidding Program, as outlined in the Bid documents.

The initial contract term shall be for one (1) year, **beginning July 1, 2025, and ending June 30, 2026**, with the option to renew for additional one-year periods upon mutual agreement. It is the intent of Dutchess BOCES to exercise such extensions provided the contractor's performance is deemed satisfactory and continuation is in the best interest of the agency. In accordance with New York State Education Law §305(14), such contracts may be renewed for an unlimited number of additional one-year terms, as is deemed prudent and cost-effective by Dutchess BOCES.

While Dutchess BOCES intends to execute extensions as described above, nothing herein shall be construed as binding Dutchess BOCES to any extension. Dutchess BOCES reserves the right to decline a contract extension for any reason permitted by law.

Boards of Cooperative Educational Services (BOCES) were established by New York State legislation in 1948 to enable smaller school districts to expand their educational offerings through shared services. In 1955, legislation was passed authorizing BOCES to provide vocational and special education. BOCES are voluntary cooperative associations of school districts within a geographic area that share planning, services, and programs to deliver educational and support services more economically, efficiently, and equitably than would be feasible independently.

BOCES programs and services include, but are not limited to: special education, career and technical education, academic and alternative programs, summer school, staff development, management and instructional technology services, educational communications, and business office support services.

This RFB is issued in compliance with New York State General Municipal Law (GML) §103 and best procurement practices.

3. SCOPE OF SERVICES

The scope of services for this RFB are to provide the services of transporting students, as required, to Dutchess BOCES and its participating Component Districts. Vendors will provide the services, as described and explained in this RFB, throughout the duration of the contract and any and all extensions.

Eligible School Districts

Use of this bid and any resulting award is limited to those school districts who are members of the Dutchess BOCES Cooperative Purchasing CoSer. Any other school district wishing to utilize this bid must first arrange for cross-contract approval through Dutchess BOCES.

The following districts are current members of the Purchasing CoSer and are eligible to purchase items from this bid; these include:

These entities are hereinafter referred to collectively as "the District(s)" throughout this RFB.

Contract Period

A period of one (1) year beginning on 1 July 2025 and running through 30 June 2026. The bid award may be extended beyond the bid period, with one (1) year extensions, by mutual consent of the successful bidder and Dutchess BOCES. The number of extensions will be determined by mutual consent of the participating parties with unlimited extensions possible pursuant to New York State Education Law §305(14)

Known Routes

A list of currently anticipated transportation routes for the District(s) will be provided as an attachment to this RFB. These routes are subject to change based on student enrollment, program needs, and participating district requirements. Contractors must review the attached route list and incorporate the scope of these routes into their pricing and service models.

Vehicles and Equipment

All vehicles used under this contract shall be:

- Fully compliant with all New York State Department of Transportation (NYSDOT) and New York State Education Department (NYSED) regulations, and possess valid and current inspection stickers.
- Clean, mechanically sound, and regularly maintained.
- Assigned to specific routes wherever feasible, and must clearly display route number signage in a visible manner.

Vehicle Age Requirement for Spackenkill UFSD:

Spackenkill Union Free School District reserves the right to require that any vehicle used on its assigned routes be no more than five (5) years old at the time of service. This shall be considered a condition of award for all routes assigned by Spackenkill UFSD and must be demonstrated prior to the start of service. Exceptions may only be granted in writing by the District.



Contractors shall provide:

- Annual BusNet fleet profiles (as submitted annually to NYSED via the NYSDOT system), including vehicle inventory and maintenance records, must be submitted to the District(s) no later than July 1st each year, or more frequently upon request.
- Vehicle repair and maintenance logs upon request.
- Vehicles for inspection prior to the start of each school year and at any time during the contract term, upon reasonable notice.

The District(s) reserve the right to remove any vehicle from service if its condition is deemed unsatisfactory. Contractors' facilities may also be inspected prior to award and at any time during the contract.

Communication Equipment

- All buses must be equipped with two-way mobile radios and a base radio system located at a site designated by the District(s).
- The contractor shall bear all costs related to installation, licensing, and maintenance.
- Cell phones may NOT be used in place of two-way radios unless specifically approved in writing by the District(s).

Video Surveillance Systems and Data Requirements

- All vehicles must be equipped with installed video surveillance systems that include both:
 - o Interior cameras covering all student areas, and
 - Exterior cameras capturing the front loading zone, rear of the vehicle, and passenger entry/exit points.
- All systems must be capable of recording both audio and video and cameras must record at a minimum of 720p (1280x720) or higher, and include time stamped video.
- Camera equipment and any recorded footage shall remain the property of the District(s) and must be made available to the District(s) upon request.
- Contractors are responsible for maintaining camera systems in working order at all times and ensuring data is accessible if requested for disciplinary, safety, or legal purposes.

Video Storage and Access Guidelines

Data Retention Period:

- Minimum Retention: Store all recorded footage for at least 30 days to ensure availability for incident review and compliance purposes.
- Extended Retention: Implement protocols for preserving footage beyond 30 days if it pertains to ongoing investigations or legal matters.

Storage Solutions:

- Cloud Storage: Cloud based storage must ensure compliance with data protection regulations and district policies.
- On-Premises Storage: If using local servers or Network Video Recorders (NVRs), ensure they have sufficient capacity and are secured against unauthorized access.



Access Controls:

- Restricted Access: Limit access to surveillance footage to authorized personnel only, such as district administrators or designated security staff.
- Audit Trails: Maintain logs of all access and actions taken with the footage to ensure accountability.

Compliance with Regulations:

- Contractors must cooperate with any district-requested redaction or controlled disclosure process for footage used in disciplinary or legal matters involving minors.
- Contractors must clearly communicate surveillance policies to students, parents, and staff, including details about the presence of cameras and the handling of recorded data.
- The successful vendor must comply with all applicable laws and regulations regarding the privacy, protection, and encryption of student data, including but not limited to the Family Educational Rights and Privacy Act (FERPA) and New York State Education Law §2-d.
- After selection and as a condition of contract execution, the selected vendor must:
 - Be listed in the SDPC database or, if not already listed, must complete the necessary TEC (Technology & Education Consortium) Standard Data Sharing Agreement as directed by Dutchess BOCES;
 - Ensure all subcontractors or third-party service providers with access to student data (e.g., routing software vendors) are also fully compliant with FERPA and Ed Law §2-d and submit documentation upon request.
 - Submit a copy of their current data privacy and security policy or plan;
 - Provide a signed Education Law §2-d Supplemental Agreement that meets the requirements of the New York State Student Data Privacy Consortium (SDPC);
 - Failure to meet these requirements within the timeframe designated by Dutchess BOCES will result in forfeiture of the award, and the contract may be offered to the next qualified and responsive vendor.

Regular Maintenance and Testing:


- System Checks: Conduct routine inspections and maintenance of camera systems to ensure proper functionality and recording quality.
- Data Integrity: Regularly verify that footage is being correctly recorded and stored without corruption.

Seasonal Safety

• During inclement weather, vehicles must be equipped with snow tires or chains as necessary to ensure student safety.

Use Restrictions

- Vehicles used under this contract may not display advertisements or political messaging.
- Use of contracted vehicles is restricted solely to transporting students district-designated personnel by the District(s). No private or compensated transport arrangements may be made using these vehicles during contract use.





Student Data Privacy and Security Compliance

Vendor agrees to comply with the requirements of New York State Education Law 2-d as more fully described in the rider attached hereto as Attachment "B". The Education Law 2-d data privacy plan requirements apply only to software and/or hardware line items that collect personal identifiable information (PII) now and/or during any extended term of this contract in the future. Successful Vendor(s) will be required to provide their Data Privacy Plan upon request by and to Eastern Suffolk BOCES and/or Participant.

4. GENERAL INFORMATION

- a. By submitting a bid in response to this Request for Bid (RFB), you are asking Dutchess BOCES to accept your offer for the sale of goods or services. It is important that you read and understand all terms and conditions contained herein, as well as understand the laws that govern Municipal Purchasing in the State of New York.
- b. Once Dutchess BOCES has opened bids, there can be no changes to price or terms outside of legally permitted final negotiations of things such as final staffing requirements, payment terms, or guarantees. In addition, there are no provisions to cancel after an award is made, except by Dutchess BOCES, which maintains a unilateral right to cancel for any reason or no reason at all.
- c. The envelope shall be clearly marked on the front with the name of person, firm, or corporation submitting the bid, and "RFB for Cooperative Transportation RFB# 2526-02 bid opening 5/6/2025 2 p.m." This includes marking the outside of any express mail envelope that may be used.
- d. Facsimile, telephone, or verbal bid or any modifications of bid documents will NOT be accepted or considered.
- e. Any contract terms or conditions added to the bid will not be binding to Dutchess BOCES.
- f. Bids received after the time stated for the bid opening date in the Notice to Vendors will NOT be considered and will be returned to the vendor unopened. The vendor assumes all responsibility for having the bid submitted on time at the place specified.
- g. No modifications or additions are to be made to the printed bid documents. In the event the vendor deems that modifications are necessary, such modifications must be set forth in writing to Dutchess BOCES in a separate document and submitted with the bid documents to be considered. However, any modifications or additions submitted may result in the bid being considered non-responsive.
- h. Dutchess BOCES will interpret the submission of a bid to mean that the vendor is fully informed as to the extent and character of the services, supplies, materials, and equipment required and that the vendor can furnish the same in complete compliance with the specifications.
- i. Vendors currently on the NYS Labor Department or Worker's Compensation Debarred Lists will not be considered for award. By submitting a bid for consideration, the vendor is indicating to the BOCES that they are currently in good standing with the NYS Dept. of Labor and Workers Compensation Board at the time of the bid.
- j. Pursuant to NYS Labor Law §220(3-a)(b) and §220-i, contractors and subcontractors performing public work must be registered with the NYS Department of Labor prior to bidding or performing work under this contract.



- k. No charges will be allowed for federal, state, or municipal sales and excise taxes, from which the political subdivisions are exempt, or for any portion of a gross receipts tax, MTA surcharge or other tax or surcharge imposed upon the vendor.
- 1. All specifications are minimum standards and accepted samples do not supersede specifications for quality unless the sample exceeds given standards, in which case deliveries must be the same identity and quality as accepted in the sample.
- m. Dutchess BOCES reserves the right to award this contract to one or more responsive and responsible bidders, if determined to be in the best interest of the District(s).
- n. Dutchess BOCES may also reject bids and purchase transportation services under an existing County or New York State contract if such services are available on equivalent terms and at a lower price.
- o. Where items or articles of equipment or supplies are designated as manufactured by a specific manufacturer, it is to be understood that the article as specified represents an accepted standard. Where certain brands of materials, apparatus, or equipment are specified, such goods have been selected in order to establish a standard for the particular service required; but it is not the intention to limit competition thereby.
- p. Compliance shall extend to all subcontractors and third-party service providers, including, but not limited to, routing software providers or student tracking systems.
- q. Selection of the awarded bid will be based on the lowest responsible bid in accordance with New York General Municipal Law §103(1) and all other applicable laws and regulations. The contract shall be awarded to the responsible bidder who submits the lowest price while meeting all specifications, terms, and conditions set forth in this solicitation.
- r. To ensure compliance, vendors must provide all required documentation demonstrating their ability to fulfill the contract's requirements at the proposed price.
- s. Prices, and all required information, except signature of Bidder, should be typewritten or printed for legibility. Illegible or vague bids may be rejected. All signatures must be written.
- t. Failure to respond to a notice of award does not release the vendor from its obligation to perform under the terms of its submitted bid. Upon notification of award, the vendor has three (3) business days to formally dispute the award in writing. If no dispute is submitted within this period, the vendor shall be deemed to have accepted the award and must fulfill all contractual responsibilities. Notice of award will be via email.
- u. The selected vendor(s) will not provide services until and unless an executed Purchase Order is presented from a duly authorized Dutchess BOCES representative, or the same from a participating school district. Even when awarded the contract, the selected vendor(s) will not consider a contract valid without an endorsed Purchase Order.
- v. It is mutually understood and agreed that the selected vendor shall not assign, transfer, convey, sublet or otherwise dispose of the contract or their right, title, or interest therein, or their power to execute such contract, to any person, company or corporation without the previous written consent of Dutchess BOCES.
- w. Bid prices shall remain firm for the initial one (1) year term of the contract.
- x. For any contract extensions, the vendor may submit a written request to adjust pricing based on the percentage change (increase or decrease) in the New York State Consumer Price Index (CPI-U), as published by the U.S. Bureau of Labor Statistics, for the preceding 12-month period. All requests for price adjustments must be submitted at least sixty (60) days prior to the renewal date and must include supporting documentation. Any such request is subject to review and approval by Dutchess BOCES. No increase will be applied automatically, and no adjustment shall take effect without prior written approval of Dutchess



- BOCES. Dutchess BOCES reserves the right to deny any requested increase, negotiate alternate terms, or require continued pricing based on market conditions or budgetary constraints.
- y. Payments of any invoice shall not preclude Dutchess BOCES or its Participating School Districts from making claim for adjustments on any item found not to have been in accordance with general terms and conditions and scope of services.

5. QUALIFICATIONS & REQUIREMENTS

The following requirements apply to all prospective vendors and are conditions of participation in this procurement. Vendors must review and comply with each provision as part of their proposal submission. Failure to meet these qualifications may result in disqualification from consideration.

Bonding

The contractor shall obtain and maintain a Performance Bond, issued by a surety company authorized to conduct business in the State of New York, in the amount of 100% of the estimated annual contract value, guaranteeing faithful performance of the contract.

- The Performance Bond must remain in effect through the term of the contract and for sixty (60) days after the contract's expiration.
- The bond shall name as beneficiaries: Dutchess BOCES, Spackenkill Union Free School District, and/or any districts approved by Dutchess BOCES to participate, as applicable.

a. Invocation of Bond

The Performance Bond (or, if applicable, Letter of Credit or Payment Bond) may be invoked by any named beneficiary upon submission of a certified statement to the issuing surety or bank stating that the contractor has failed to perform in accordance with the contract terms.

The surety company must have a rating of "A-" (Excellent) or better in the current edition of A.M. Best's Insurance Guide.

b. Timing and Renewal

The initial Performance Bond must be submitted to Dutchess BOCES and/or the applicable school district no later than thirty (30) days prior to the commencement of services.

A renewal bond must be submitted at least thirty (30) days prior to the start of each subsequent contract year.

Failure to provide the required bond or renewal within the specified timeframes may result in termination of the contract at the sole discretion of Dutchess BOCES and/or the participating school districts.

c. Letter of Surety with Proposal

Each bidder shall submit with its proposal a letter from a licensed surety company indicating that a Performance Bond or Letter of Credit will be issued if the contractor is selected for award.

6. CONTRACTOR RESPONSIBILITIES



Adequate provisions shall be taken by the contractor for service to the Dutchess County Board of Cooperative Educational Services in the performance of the regular bus run at times other than scheduled, which may be required by delayed openings and emergency closings due to the changing weather conditions, curriculum days, or other reasons deemed necessary by Dutchess County BOCES.

PERSONNEL REQUIREMENTS

District(s) reserve the right at any time to require that any driver employed under this contract report for a physical examination, at the District(s) expense, by a physician designated by the District(s). Driver records will be available to the District(s) for inspection prior to the opening day of school or operating a vehicle under this contract, whichever is sooner.

The contractor agrees that all drivers it employs under this contract shall undergo periodic and/or random drug/alcohol testing at no cost to the District(s). The Contractor must test drivers according to all applicable current State and Federal Regulations.

Contractor shall prohibit employees under this contract from consuming any drug, controlled substance or intoxicating liquor, or being under the influence of any intoxicating liquor or drug while on duty or within eight (8) hours before going on duty or operating any vehicle pursuant to this contract and in compliance with Federal and State regulations.

DRIVER REGULATIONS

Article 19A of the Vehicle and Traffic Law and all other rules and regulations of the New York State Department of Transportation pertaining to school bus drivers must be complied with. All State Education Department regulations for school bus drivers must be complied with. The contractor represents that they have reviewed the requirement of Article 19A and the regulations of the New York State Department of Transportation and agree to comply therewith. All regular substitute or replacement drivers are required to complete the basic driver safety training course. Drivers may also be required to attend training school and meetings, as required by the District(s) officials at no additional costs to the District(s).

Each driver shall receive at least two (2) hours of instruction on school bus safety practices prior to transportation of any pupils. All drivers shall receive refresher instruction in school bus safety at least two (2) times a year. One session shall be conducted prior to the first day of school, and the second session shall occur prior to February 1st at the contractor's expense. Drivers of disabled pupils will be required to attend an additional one (1) hour session in the safe transportation of disabled pupils.

School bus drivers must be at least 21 years of age.

The successful bidder must provide the District(s) with a list of names, addresses and further documentation of all drivers, including an abstract of drivers' licenses. The above documentation is to be presented prior to implementation of any contract. The successful Bidder will provide the District(s) with a list of drivers and route number and bus number they drive as changes occur. Copies of required records under Article 19A and Commissioner's Regulation 156.3 must be provided to the District(s), as stated above.

After reviewing driver records, the District(s) will approve all drivers, substitutes, and, or replacements prior to their driving. The District(s) reserves the right to remove any driver when in the judgment of the District(s) such driver represents a threat to the safety, morals, or other



well-being of the students. The contractor shall take immediate steps to replace any driver pursuant to this paragraph.

REQUIRED LICENSES

Each driver of a vehicle conveying school children shall have the appropriate license to operate said vehicle and any special license and/or endorsement as required by the State of New York. Initial copies of current licenses and renewal(s) shall be provided to the District(s).

All bus drivers are expected to maintain discipline, and to report all cases of disobedience to the administrator(s) of the school concerned on the forms provided by the Contractor. Copies of such forms should be immediately sent to the District(s), attending School Administrator, Participating School Transportation Supervisor, and include the Route Number, name of student(s) involved, date and description of incident. Contractor is responsible for maintaining a master file of all completed forms by Route Number.

All bus drivers must take any mandated or refresher courses or attend any meeting prescribed by the District(s).

SAFETY PROCEDURES

- School transportation vehicles must be operated at all times by capable and competent personnel at safe and reasonable rates of speed.
- The District(s), through its officials, reserves the right to enforce any and all provisions of safety in the transportation of pupils to and from school.
- All pupils are to enter and leave the vehicle at the curb.

EMERGENCY CLOSINGS/DELAYED OPENINGS

Adequate provisions shall be taken by the contractor for service to the District(s) in the performance of the regular bus run at times other than those scheduled, which may be required by delayed openings and emergency closings due to the changing weather conditions, curriculum days, or other reasons deemed necessary by the District(s).

ROUTE SCHEDULE

Routes will be based on 125 live miles and five (5) hours of billable driver and, if applicable, monitor time. Live miles are defined as the distance starting at the first student pick-up point and ending at the last student drop-off point. Five (5) hours of billable driver and, if applicable, monitor time will be calculated from the contractor facility closest to the first morning student pick-up, through the entire route, and return to the contractor's starting facility. Afternoon hours may be different from morning hours due to different student riders or route combinations, but must originate from the same contractor facility as the morning route, and will be calculated in the same manner. Hours in excess of five (5) per day will be charged and paid according to the bid offer, provided the route is calculated only from the contractor's closest facility.

The Contractor, acting in conjunction with the District(s), will provide details of the route schedule(s) for all regularly scheduled transportation to and from the attending schools. The route schedule(s) will contain the length or duration of individual routes, direction of travel, student address, phone, parent/guardian name, name and location of attending school, time of pick-up and drop-off of student's residence and attending school, location of student pick-up and drop-off points, and a breakdown of all route charges (i.e. base rate, monitor cost, extra mile(s), extra driver time, tolls, etc). It is understood that the number of student riders may vary during



the period of the Transportation Contract. For all routes, the path of travel will be the shortest, most practical route. The District(s) will have the final determination on the path of travel. Should the contractor or any driver employed under this contract choose to travel a different path of travel without the written consent of the District(s), the contractor will be responsible for any and all additional costs such as additional driver time, monitor aides time, tolls, and mileage.

Whenever possible, the route schedule will provide for delivery of students, to their respective schools, ten (10) minutes prior to the start of the school day. Pickup of students after school is planned for the published dismissal time of the particular building serviced. In the event bus routes need to be added, modified, or deleted to accommodate the needs of a participating district, the contractor must immediately notify the District(s), and any related route cost adjustments shall be made as follows:

In the event that any route or portion of a route is changed during the contract period, the amount of compensation paid to the contractor may be adjusted. Any increase or decrease in the cost of the route will become effective on the exact date of the change. Adjustments are to be made accordingly to any of the following cost areas:

Base Contract (Daily Rate)

Cost of General monitor aides

Added Shuttle Cost Added Tolls

Added Miles Cost Cost of Special monitor aid

Added Shuttle Time Charge Fuel Provision Calculation (based on

Added Driver Time mileage)

Bus contractors must not combine any routes or deviate from prescribed routing at any time without the written permission of the District(s).

If, in case of inclement weather or emergency, a driver cannot complete a portion of the assigned route at the assigned time, the driver/contractor must notify the PARTICIPATING SCHOOL DISTRICT TRANSPORTATION SUPERVISOR AND DUTCHESS BOCES immediately so they may in turn notify the students involved of the necessary changes and adjustments.

All incidents of equipment failure that result in delays or inability to continue a route must be reported immediately by radio or phone to the District(s). Upon notification that a vehicle is inoperable, the contractor shall immediately dispatch a replacement vehicle to provide the required services.

ACCIDENTS

In the event of an accident, the Contractor must immediately notify, by telephone, Dutchess BOCES AND the District(s) on that route of any accident involving a school bus whether or not students were involved. A copy of Form MV-104 must be filed with the District(s) with copies sent within 24 hours, without regard to whether such form is required by any other agency.

INJURIES

In the event of an injury, the Contractor must immediately notify, by telephone, Dutchess BOCES AND the District(s) of the injured student(s) on that route. Written reports of such injuries must be submitted within 24 hours to Dutchess BOCES AND the participating district(s) of Student(s).



A listing of personnel for Emergency Contacts will be provided to the contractor prior to commencement of service, and the contractor must contact all designated emergency school district personnel in the event of any accident or injury.

SCHOOL DAY

Transportation is to be provided in accordance with the Special Provisions of the Transportation Specifications. However, in the event that changes in the duration of the school day, or the starting and dismissal times of any of the schools are made, the contractor will be required to provide service according to any modified school day plan, until such time as the normal school pattern can be re-established. No increase in daily compensation rate shall be made should this situation occur, nor shall a decrease in compensation rate be made in the event that the modified school day plan requires fewer miles of daily driving for a vehicle.

Pupils attending non-public schools and schools out of their school district of residence shall be transported on days when their home district is scheduled to be in session, except when their school district of residence is closed due to emergency weather or other emergency conditions. Except for legal holidays, the participating district may, at its option, provide transportation for pupils attending non-public schools and schools out of their district of residence when the home district's schools are not scheduled to be in session. Transportation for handicapped students will be in accordance with legal requirements.

PROVISIONS FOR FUEL

All bids will be offered with the District(s) supplying the fuel.

Each contractor will be responsible for having its own storage tank and pump at its own expense.

Gasoline will be provided on the basis of four (4) miles per gallon on 66 passenger buses or larger, and twelve (12) miles per gallon on station wagons, vans, carryalls and similar vehicles.

Diesel fuel will be provided on the basis of seven (7) miles per gallon on 66 passenger buses or larger, and fifteen (15) miles per gallon on station wagons, vans, carryalls and similar vehicles

Where reimbursement for fuel is applicable under the contract, the bidder will be reimbursed for fuel at the New York State Contract rate. Based on the Rate in effect on that date, the rate is set on the first business day of each month and will remain in effect for the duration of that month.

For the purposes of this bid, live miles are defined as the distance starting at the first student pick-up point and ending at the last student drop-off point. Deadhead miles are not to be included for calculating fuel eligible mileage.

BOCES and/or participating districts reserve the right to request fuel usage logs and to audit fuel consumption and mileage records related to the routes at any time during the contract term.

- (a) If the District(s) awards this contract WITHOUT FUEL provided by the District(s) the contractor will provide any and all fuel needed to complete all bus routes at their sole expense.
- (b) If the District(s) awards this contract WITH FUEL provided by the District(s) the District(s) will provide fuel according to the mileage calculation of the contracted routes as described. The District(s) will audit each route for total mileage usage. Fuel provision will be based upon and calculated as follows:
 - 1. To determine total number of fuel eligible miles for any given route, multiply per trip live miles, times the number of daily trips, times the number of school days. This total mileage



figure is divided by the miles per gallon of the vehicle as set forth in the above Section. The final figure is the total number of gallons of fuel the BOCES will provide to the Contractor.

The Contractor must contact a designated agent of the District(s) to request the delivery of fuel. Approximately two (2) days notice is necessary prior to the requested delivery date. The delivery of fuel will only be authorized by a designated agent of the BOCES from a fuel vendor determined by the BOCES. Only the District(s) are authorized to order or purchase fuel under this contract from the District(s) vendor(s).

MONITOR AIDES

The contractor shall provide Monitor Aides for routes as specified and authorized by the District(s). Routes may require 1-1 monitor aides, or one monitor aide per bus route. Substitutes must be provided by the Contractor in the event an assigned monitor aide is not able to perform, for any reason. In special circumstances, as determined by the District(s), the District(s) reserves the right to supply monitor aides on any given route at no cost to the contractor.

EXTRA-CURRICULAR AND SPECIAL EDUCATION TRANSPORTATION

The District(s) reserves the right to establish, from time to time, transportation services for pupils for special education needs, athletic functions, music rehearsals, clinics, field trips and the like. Contractors providing this service shall be compensated at the rate awarded pursuant to Bid whichever the District(s), in its discretion, awards.

Luggage space necessary to carry equipment and instruments for such transportation shall be provided in accordance with the New York State Department of Transportation regulations.

PUPIL ATTENDANCE ROSTER

Daily pupil attendance rosters will be maintained by all drivers assigned to regular routes, or their substitute if applicable. These rosters **must be completed and signed daily by the drivers**. Copies of all such rosters shall be submitted to the District(s) no later than five days after the month is completed.

A verified student count, by individual routes, must be submitted using the student enrollment of each route on the first Monday of each month. This count must be provided to the District(s) by the 10th of the month. This information shall be provided to the District(s) on a hard copy (scanned and emailed is acceptable) report generated from a computer software program such as excel, or a database program. This report must include the number of students enrolled as of the first Monday of each month and listing for each district, numbers of students and corresponding route numbers.

SHUTTLE/FEEDER ROUTES

Some routes servicing multiple schools or picking up students from many different home schools become too long to be practical. To shorten ride times and make the main routes more efficient, shuttle/feeder buses have been used effectively to deliver students from home to the main route bus, somewhere along the route. It is anticipated that the use of these shuttle/feeder vehicles might be required in this contract period as well.



Payment for the use of a contractor owned vehicle in each shuttle/feeder service will be at an hourly rate identified in the bid. This payment will not apply when a contractor vehicle performs a shuttle/feeder route while already in service on another route under this contract.

Shuttle/feeder routes require prior, express written consent, of the District(s).

MISCELLANEOUS

Bidders are advised that the information herein is for the bidding purposes only and is subject to change, and that the bidders are required to make themselves knowledgeable of the calendar and procedures of the various schools, as well as the starting and dismissal times.

Transportation must be in strict accordance with these bid documents, and the contract will be subject to the approval of the District(s) as well as the Commissioner of Education. Should any dispute arise respecting the true construction, meaning and interpretation of these bid documents and contract, interpretation shall be made by the Dutchess County BOCES purchasing agent or business official.

It is also agreed that the successful contractor hereby consents to an audit by the New York State Department of Audit and Control and/or Dutchess BOCES of any and all financial records related to the awarding of this bid or to financial records related to the implementation of the contract after the award of the contract.

As described above, the District(s) may add and/or expand bus routes as well as require additional buses for pupil transportation services as conditions may require.

7. CONTRACT RETENTION & TERMINATION CONDITIONS

The following conditions govern the continued retention of any contract awarded under this RFB. The District(s) reserve the right to terminate the contract, in whole or in part, under the following:


a. Regulatory Compliance

The contract shall be considered null and void at any time the New York State Department of Motor Vehicles or New York State Education Department refuses to approve the contractor, the contract, or any conveyance used for student transportation. Additionally, failure by the contractor to comply with any applicable federal, state, or local regulations, or statutory provisions of the State of New York, shall constitute a breach of contract.

b. Service Failure

If the contractor is unable or unwilling to transport all scheduled students on any assigned route for three (3) consecutive school days, the District(s), at their sole discretion, may terminate the contract or the affected route(s). In the event of such termination, the District(s) may procure alternative transportation, and any cost incurred in excess of the contractor's agreed-upon daily rate shall be the financial responsibility of the contractor.

The District(s) also reserve the right to cancel any individual route or portion of the contract without terminating the full agreement if doing so is deemed in the best interest of the District(s), subject to the same remedies as described above.





c. Additional Service Requirements

If the District(s) require additional routes or buses, a Student Add/Delete form will be completed to initiate the request. The contractor must begin providing the requested service by the fifth (5) school day after notification. Failure to do so shall constitute a Service Failure as defined in Section 6.b and will be subject to the applicable penalties outlined therein.

8. INSURANCE & COMPLIANCE REQUIREMENTS

The successful bidder shall procure and maintain, at its own expense, insurance of the types and amounts described below, issued by companies authorized to do business in the State of New York. A valid certificate of insurance, including all required endorsements, must be submitted with the bid to Dutchess BOCES.

A. Commercial General Liability Insurance

- a. Minimum limits of \$1,000,000 per occurrence and \$2,000,000 aggregate.
- b. Coverage must include: bodily injury, property damage, and products/completed operations liability

B. Automobile Liability Insurance

- a. Minimum limits of \$5,000,000 combined single limit per accident.
- b. Coverage must apply to all owned, hired, and non-owned vehicles used in the performance of this contract.

C. Workers' Compensation and Employers' Liability Insurance

a. As required by the laws of the State of New York.

D. Additional Insured Requirement

- a. Policies must name **Dutchess BOCES** and any of its **participating component school districts** as additional insureds on the Commercial General Liability and Automobile Liability policies.
- b. Insurance certificates must include endorsement pages verifying the additional insured status.

E. Certificate of Insurance

- a. A valid certificate of insurance must be submitted with the bid.
- b. Any participating district utilizing this cooperative contract reserves the right to request and receive its own certificate of insurance naming it as an additional insured.

F. Cancellation Clause

a. Each insurance policy shall include a provision that the insurer will not cancel or materially alter the coverage without providing at least thirty (30) days' written notice to Dutchess BOCES.

G. Termination of Insurance Coverage:

At all times during the contract term, the contractor must maintain the insurance coverage required under this RFB. Any cancellation, non-renewal, or lapse in required insurance coverage shall constitute a material breach of contract and may result in immediate termination of the contract at the sole discretion of the District(s).

Dutchess BOCES and the appropriate participating district(s) must be named as an additional insured on all applicable policies and proof of continuing coverage in the amounts set forth shall



be produced upon renewal and/or upon demand by the BOCES prior to the expiration date of the existing certificate.

Dutchess County BOCES and its participating school districts will be held harmless in the event of a claim or cause of action resulting from an accident or injury by the contractor.

9. DISPUTE RESOLUTION

To attempt dispute resolution, the process included in this section will be used under this bid award/contract.

Dutchess BOCES and the vendor attempt to resolve the dispute in good faith.

Any dispute arising from this contract shall be resolved by binding arbitration administered in Dutchess County, New York. The arbitrator shall be mutually agreed upon by the parties, or if no agreement is reached, selected in accordance with the procedures of the American Arbitration Association (AAA). The arbitrator's decision shall be final and binding. Each party shall bear its own costs unless otherwise directed by the arbitrator. Judgment may be entered in any court of competent jurisdiction.

10. AWARD AND RESERVATION OF RIGHTS

The award of this contract shall be made to the lowest responsible and responsive bidder whose bid meets the requirements and specifications set forth in this RFB. While price is a significant factor, the District(s) reserve the right to consider additional criteria in determining responsibility, including but not limited to:

- Company reputation and demonstrated performance on prior transportation contracts
- Financial stability and legal standing
- Compliance history with federal and state transportation laws and regulations
- Ability to meet service requirements, including vehicle standards, staffing, and timelines

The District(s) reserve the right to reject any or all bids, to waive minor irregularities, and to award a contract deemed to be in the best interest of the District(s), in accordance with New York State General Municipal Law §103 and Education Law §305(14).

Conflicting Terms

In the event of a conflict between the General Terms and Conditions and the detailed Bid Specifications, the provisions of the Bid Specifications shall prevail.

Dutchess BOCES also reserves the right to resolve any ambiguity or conflict in the bid documents in the manner deemed most favorable to the agency as determined by the purchasing agent or business official.

Any terms submitted by the vendor that conflict with the terms of this solicitation shall be deemed void and without effect unless expressly accepted in writing by Dutchess BOCES.



Timing

Dutchess BOCES may make awards within ninety (90) days of bid opening. Bids may not be withdrawn during this period.

11. PAYMENTS

No payments can be made without an itemized invoice against a properly issued purchase order, and the contractor acknowledges that services are not to be provided until and unless they received a properly issued purchase order.

Only items covered under this agreement are to be invoiced and no payment will be made for "off contract" items unless approved in writing in advance.

If the contractor is unable or unwilling to transport students on any school day during the term of the contract—whether due to vehicle breakdowns, mechanical issues, unsafe equipment, negligence, labor disputes (including strikes), civil disturbances, acts of God, or any other cause the contractor shall not be entitled to compensation for that route for that day.

- In addition, any costs incurred by BOCES as a result of the contractor's failure to provide transportation shall be charged to the contractor and may be deducted from future payments. If no future payments are due, the contractor shall remit payment in full to BOCES within thirty (30) days of notification.
- The contractor shall also be responsible for any reasonable legal fees or costs incurred by BOCES in connection with such failures to perform.
- The deduction from contract payments by reason of the contractor's inability or unwillingness to transport students on established routes shall be based upon the total daily rate for each route not performed according to the current or most recent monthly billing, or the cost incurred by the District(s) performance of the contractor's route(s), whichever is greater.

Payments to contractors will be on a monthly basis no less than forty-five (45) days after receipt of itemized bills from the vendor. For the month of June of any given year, all invoices must be in the District(s) Business Office no later than two (2) business days after the last day of student transportation.

NON-APPROPRIATION CLAUSE

In accordance with New York State General Municipal Law, Dutchess BOCES shall not be held liable for any purchases or contracts for which funding is unavailable or withdrawn prior to issuance of a purchase order. Vendors agree to hold Dutchess BOCES harmless for any commitments made in the absence of an authorized purchase order.

The issuance of a purchase order indicates that funds have been encumbered for the stated goods or services. In the event a project or purchase must be canceled after issuance, Dutchess BOCES shall only be liable for actual, documented costs incurred up to the time of cancellation. No additional claims for anticipated profit, restocking fees, or future damages shall be honored.



PERFORMANCE PENALTIES

In the event of contractor non-performance, the District(s) may impose penalties, which shall be assessed per occurrence, per day, and deducted from the contractor's subsequent monthly invoice following identification of the failure. Penalties shall apply as outlined below:

- a. Failure to Provide Required Contract Documents (e.g., insurance certificates, student counts, etc.) \$100.00 per day past the due date per missing item.
- b. Failure to Provide & Comply with Driver Requirements \$100.00 per driver record out of compliance.

The District(s) also reserve the right to suspend or remove any non-compliant driver from service.

- c. Failure to Provide Certificate of Insurance \$100.00 per day past the due date.
- d. Failure to Submit Student Counts \$100.00 per day past the due date.
- e. Failure to Submit Final June Invoice by Required Deadline \$250.00 per day past the due date.
- f. Failure to Provide Monitor/Aide \$100.00 per day per assigned route where no aide is present.
- g. Failure to Report Accidents or Injuries to the District(s) \$500.00 per unreported incident.
- h. Failure to Provide an Additional Route \$100.00 per day the requested route is not available.
- i. Unauthorized Route Changes or Combinations \$100.00 per day for any route that is modified.

The District(s)' decision not to impose a fine for any specific incident does not waive the right to impose penalties for future or repeated violations.


